CALL TO ORDER

Kathy Flaherty, Chair, called the meeting to order at 2:00 pm.

APPROVAL OF AGENDA

A motion was made / seconded, (Bob Boesch / Alfonse Peterson) to approve the July 25, 2024 agenda as presented. Motion carries.

PUBLIC COMMENTS

APPROVAL OF MINUTES

A. Approval of June 27, 2024 Board of Directors Meeting Minutes, Exhibit 1

A typo was corrected on page 5.

A motion was made / seconded, (Gary Bacom / Bob Boesch to approve the June 27, 2024 Board of Directors Meeting minutes with correction, Exhibit 1. Motion carries.

FINANCIAL REPORT

A. Approval of June 27, 2024 Finance Committee Meeting Minutes, Exhibit 2

A motion was made / seconded, (Alfonse Peterson / Gary Bacom) to approve the June 27, 2024 Finance Committee minutes as presented. Motion carries.

B. June District Financials, Exhibit 3

Dawnita Castle reported that this is the end of the fiscal year and there may be a few invoices that will need to be accrued. YTD has a net profit of \$720,676, which will decrease as the auditor reviews and provides suggestions as he can adjust.

June 2024 Cash Balance was \$4,303,753 and Days Cash On Hand decreased to 492 days compared to 504 days in May. The decrease was due to some large payments to Clark Pest Control, Carrier and Johnson Controls. She did a cash ratio which measures BMHDs ability to pay off their debts and they are very strong.

Investments have increased and are generating interest. The LAIF account that was at Westamerica Bank is now a Money Market Account at PNC Bank and has generated \$4,000 in interest for the month.

YTD net profit is \$720,676 and a loss for the month of \$15,000 due to a few payments for repairs and maintenance, and \$26,000 to Carrier for the Castle Site and there were gains in investments, it was \$87,000 less than the prior month.

She reviewed the budget as Buffy McDaniel had a couple of questions last month. On Misc Operating Revenue and Rental Income Buffy McDaniel thought there was \$92,000 and now that there has been a full 12-months, it gained \$53,000 more than what was budgeted. Expenses came close, they were over budgeted by \$81,000. The gains and losses were budgeted to actual for 2023 and BMHD made \$477,000 more in gains for the year.

C. June Payroll, Electronic Payments & Check Register, Exhibit 4

A motion was made / seconded, (Alfonse Peterson / Bob Boesch) to approve and accept the June total payroll in the amount of \$12,445.62; total accounts payable of \$301,531.51 for a grand total distribution of \$313,977.13, Exhibit 4. Motion carries.

CHIEF EXECUTIVE OFFICER REPORT

A. Facilities Report

Kory Billings reported that with Clark Pest Control's recommendation of tenting the facility, we were quite busy. We removed the majority of items from our portion of the facility. R&C Fume, Inc, began tenting began on Friday, July 19 and ended on Monday, July 22 around 10am. Once we received all clear, tenants were informed.

R&C Fume, Inc, were concerned about the roof as its Spanish tile. They did not break any tiles, but some of the tiles did slip and they were able to tag those for us. We will contact our roofing company and get these taken care of.

Heating and AC came out today to replace filters and fix a minor leak and they did not see any indication of anything in the attic. The hope is that everything has been eradicated.

Our tenant, Blue Cloud, children's dental surgery center has had several inspections and they failed in emergency exit lighting and backup systems. A lot of it has to do with Blue Cloud and some with us. They are required to have lighting that comes on in the hall and that lighting can't be attached to the general power. It has to be connected to a backup generator and also to

a backup battery system. The surgery center took the report and sent it to their company, it's a very confusing report and this is a cost of \$90,850. There are ballasts that no longer meet requirements, generator lighting is inappropriate, etc. They are not asking us to cover all the expenses, but some items are our responsibility. Kory Billings will continue to work with Blue Cloud.

A thank you note was received from the Merced Running Club for BMHD's generous donation for the 4th of July run. Despite the heat this year they had 412 participants. Our name was prominently displayed in the back of each shirt.

The sponsorship check reached Washington, DC and they are in the process of making the yard signs and will ship to Kathy for display.

APPOINTMENTS / CEREMONIAL MATTERS

Kory Billings stated that as the year comes to an end, our relationship with CFHC, specifically with the finance department, payroll and accounting. They have done tremendous a job and continue to do a tremendous job in making sure that he understands where things are going. And for making sure that the board members questions are answered.

He presented Dawnita Castle with Certificates of Recognition for Christina Ayala, Payroll; Kevin Kelleher, Accountant and Sandie Cook who reconciled accounts and asked that she present these to the staff on behalf of BMHD. He also presented Dawnita Castle with an etched crystal gift in recognition of service to BMHD. Dawnita Castle thanked Kory Billings and the Board of Directors. She was born here at Bloss Memorial District Hospital and has enjoyed working with everyone. She was originally hired by BMHD just as they were filing a d/b/a Castle Family Health Centers. Her commitment is to the health care in this community, and she is glad that BMHD feels the same.

A motion was made / seconded, (Kory Billings / Kathy Flaherty) to accept and approve the June 27, 2024 Finance Committee Meeting minutes as presented, Exhibit 1. Motion carries.

REVIEW OF JUNE DISTRICT FINANCIALS, EXHIBIT 2

Dawnita Castle reported that YTD fiscal ending she will be working with Kory Billings as a few invoices for June may come in. She has a password for him so that he may accrue those invoices.

YTD profit was \$720,676 after depreciation and there will be a couple of invoices coming in but nothing that will affect the bottom line. BMHD had a total net loss before depreciation of \$8,268 for the month compared to a gain of \$8,782 last year. Review of the financial performance for June highlighted a loss due to \$20,000 in repairs and maintenance costs to Carrier and a decrease in gains from investments.

The June Operating Cash Balance was \$4,303,753 and Days Cash on Hand increased to 492 days versus 504 days in May. There were larger payments to Clark Pest Control, Johnson Plumbing and Carrier.

The current ratio, which is paying off your liability by taking your current assets and dividing that by your liabilities, BMHD is at 200. The cash ratio is also good, which is all of the District cash and the investments would cover all of the liabilities.

Alfonse Peterson asked if the cash that was going into PNC get done. Kory Billings stated that as of this morning the interest on the money that we do have at PNC was over \$4,000.

A motion was made / seconded, (Kory Billings / Kathy Flaherty) to approve and accept the Review of June District Financials, Exhibit 2. Motions carries.

WARRANTS & PAYROLL

A. June Payroll, Electronic Payments & Check Register, Exhibit 3

A motion was made / seconded (Kathy Flaherty / Kory Billings) to approve the June 2024 Payroll in the amount of \$12,445.62; Accounts Payable in the amount of \$301,531.51 for total disbursement of \$313,977.13, Exhibit 3. Motion carries.

Manufacturer has the right to inspect the premises and/or receive tiles from the structure to evaluate the applicability of this warranty, and provided a verifiable manufacturing defect for which warranty protection is provided hereunder is established, then within 90 days from the date of inspection and/or testing of the tiles, Eagle Roofing Products Florida LLC will coordinate with a local roofing material supplier and/or roofing contractor to provide to the Warranty Holder (at Manufacturer's sole election) either (i) replacement tile, matching color, shape and texture as close to the original as is currently available, or (ii) the refund at the current Manufacturer's distributor cost for replacement tile, matching color, shape and texture as close to the original as is currently available, with respect to the tile that exhibits a verifiable manufacturing defect for which warranty protection is provided here under.

Manufacturer further agrees that, during the first ten (10) years following original installation (but only for that period), this limited product warranty will also include all reasonable costs associated with the labor to remove any defective tiles, loading and installation and installation of replacement tiles, and freight, underlayment, nails and other components materials required by local building codes in connection with the replacement, but only when and to the extent verified manufacturing defects cause intrusion of water into the structure and the defective condition of the tile was not obvious prior to installation. (This additional warranty does not obligate Manufacturer to provide replacement tiles; per the preceding paragraph, it may still provide a refund for tile at the current Manufacturer's distributor cost.)

Manufacturer's warranty, as provided herein, only applies to the specific tiles for which a verifiable manufacturing defect covered hereby is established; this warranty does not provide for the replacement or the cost to replace adjacent tiles.

This warranty is automatically transferred to the subsequent owners through the sale or transfer of the individual structure provided that the original warranty was properly registered within 18 months of the inceptive delivery of the roof tiles to the structure.

Specific exclusions include any representation or warranty relating to color, surface cracking, chipping, topical slurry coating delamination, efflorescence, carbonation, oxidation or failure of other materials used as components of the roof or structure, installation not in accordance with TRI (Tile Roofing Institute) Installation Manuals or local building codes at the time of installation, damage to the tile caused by roof traffic or other trades, failure to comply with the recommendations set forth under "Owner Information", or foreign objects falling on the roof, ice build-up and damage to the tile or structure caused by corrosives, fire, hurricanes, hail, tornadoes, earthquakes or other acts of nature or God.

MANUFACTURER SHALL NOT BE LIABLE FOR ANY INJURY OR DAMAGE TO THE STRUCTURE UPON WHICH THE Eagle Roofing Products Florida LLC HAVE BEEN APPLIED (INCLUDING ANY PROPERTY LOCATED THEREIN), OR TO PERSONS ARISING OUT OF THE USE, INTENDED USE, INSTALLATION OR APPLICATION OF SAID PRODUCTS. THIS WARRANTY SPECIFICALLY EXCLUDES ANY AND ALL DAMAGES TO PERSONS OR PROPERTY WHICH RESULTS FROM THE PASSAGE OF WATER THROUGH THE BODY OF THE TILE.

Eagle does not warrant color due to the tile exposure to the elements. Variations in sand, cement and coloring oxides may also cause texture and/or color shading during the manufacturing process. This variance is not detectable through standard quality control practices. Please note that installation of our roof tiles constitutes acceptance. It is the responsibility of the installing roofing contractor/general contractor and/or homeowner to inspect, select and place roofing tiles in a manner that will optimize the beauty of the roof and to ensure the desired appearance.

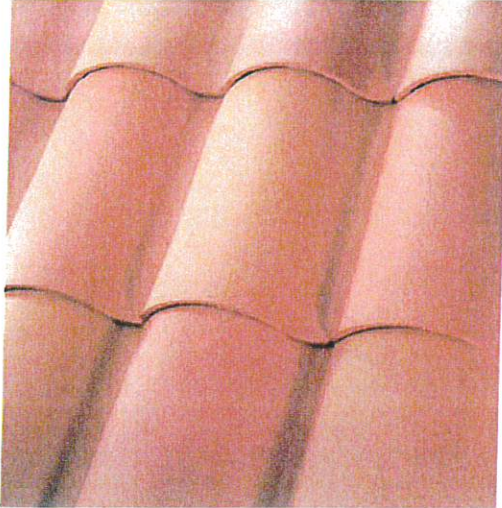

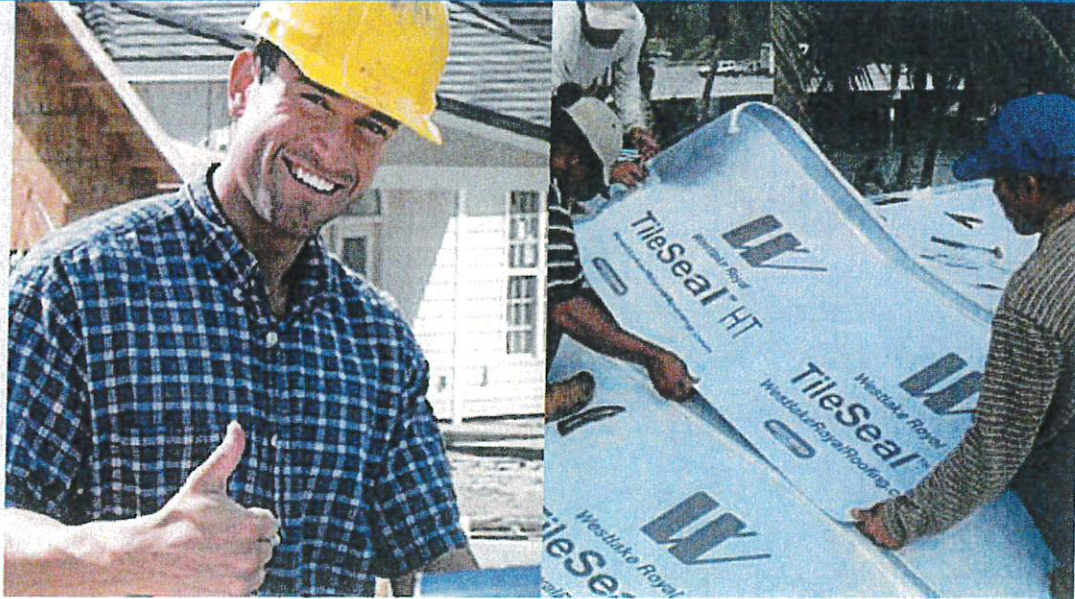

WARRANTY PERIOD

This warranty is not transferable by the Original Owner. The warranty period starts at the completion of the proper installation of the Westlake Royal TileSeal™ HT and, unless terminated at the sale of the property upon which the product is installed, expires at the end of thirty (30) years.

EXCLUSIVE REMEDIES

If at any time during such thirty (30) year period the Westlake Royal TileSeal™ HT does not perform as warranted, OWENS CORNING will repair or replace at OWENS CORNING's discretion Westlake Royal TileSeal™ HT in exchange for and to the extent that the Westlake Royal TileSeal™ HT is found by OWENS CORNING not to comply with this warranty. OWENS CORNING's maximum liability is limited to the original purchase price of the Westlake Royal TileSeal™ HT, prorated and reduced at a rate of 5% for each year of service after the first ten (10) years from the effective date of this warranty.

LIMITATIONS AND EXCLUSIONS

OWENS CORNING will not be liable for, and this warranty does not cover:

1. Consequential or special damage of any kind, including (but not limited to) damage to the interior or exterior of any building or to any property contained in or near it.
2. Damage to the Westlake Royal TileSeal™ HT resulting from causes beyond normal wear and tear including (but not limited to):
 - a. Hailstorms or other unusually strong storms, high winds or act of God.
 - b. Impact of foreign objects.
 - c. Traffic on the roof.
 - d. Improper handling, storage, or installation of the Westlake Royal TileSeal™ HT.
 - e. Improper design.
3. Replacement or failure of any product used on the roof that was not manufactured by OWENS CORNING.
4. Damages to the roof resulting from anything other than an inherent manufacturing defect in the Westlake Royal TileSeal™ HT including (but not limited to):
 - a. Defects in, failure, or misapplication of material used as a roof base.
 - b. Application of solvents, paints, cleaning solutions or coatings.
 - c. Settlement or movement of the building, walls, foundation, or roof deck.
 - d. Inadequate roof drainage. No ponding water may be evident 48 hours after a rainfall.
 - e. Subsequent structural changes or alterations, including (but not limited to) installation of equipment on the roof or any other modification such as antennas, air conditioning equipment, or solar collectors.
5. Any costs incurred for repair or replacement not authorized in writing by OWENS CORNING.
6. Workmanship defects.
7. Material not installed in strict compliance with the specifications and instructions in force at the time.

WARRANTY MODIFICATION

No agreement varying, extending or modifying the terms, conditions and remedies of this warranty shall be binding upon OWENS CORNING unless in writing, signed by a duly authorized officer of OWENS CORNING.

CLAIM NOTIFICATION

To make a claim under this warranty, you must do so within 30 days after you discover the problem. To fully evaluate your claim, we may ask you to provide, at your expense, pictures of your roof or roofing material samples for us to test. You must do so in order to be eligible to make a claim under this warranty. To make a claim or if you have any questions, call us at 1-800-ROOFING or visit us at www.owenscorning.com/roofing. If you repair or replace your Owens Corning products before Owens Corning has made a determination on your claim, your claim may be denied. Owens Corning shall have a reasonable time after notification of a claim to inspect the roof. If requested by Owens Corning, the owner shall provide Owens Corning with reasonable access to the roof, during normal business hours, for the purpose of conducting an inspection of the roofing products.

SOLE AND EXCLUSIVE WARRANTY

THIS LIMITED WARRANTY IS ISSUED AND ACCEPTED AS EXCLUSIVE AND REPLACES ALL OTHER WARRANTIES, WHETHER EXPRESSED OR IMPLIED, INCLUDING THE IMPLIED WARRANTY OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE. THIS WRITTEN WARRANTY IS YOUR EXCLUSIVE WARRANTY FROM OWENS CORNING AND REPRESENTS THE SOLE REMEDY AVAILABLE TO ANY OWENS CORNING ROOF OWNER. OWENS CORNING MAKES NO OTHER REPRESENTATION OR WARRANTY OF ANY KIND OTHER THAN THAT STATED HERE. OWENS CORNING WILL NOT BE LIABLE IN ANY EVENT FOR CONSEQUENTIAL OR INCIDENTAL DAMAGES OF ANY KIND, WHETHER FOR BREACH OF THE WARRANTY, NEGLIGENCE, STRICT LIABILITY IN TORT OR FOR ANY OTHER CAUSE. SOME STATES DO NOT ALLOW FOR THE EXCLUSION OR LIMITATION OF INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE EXCLUSIONS OR LIMITATIONS MAY NOT APPLY TO YOU. THIS WARRANTY GIVES YOU SPECIFIC LEGAL RIGHTS AND YOU MAY HAVE OTHER RIGHTS WHICH VARY FROM STATE TO STATE.

TRANSFERABLE LIMITED CLAY PRODUCT WARRANTY

US Tile® clay roof tiles are warranted to you, the original property owner(s), by the manufacturer, Westlake Royal Roofing Solutions™ ("Westlake Royal"). Westlake Royal warrants that the clay tiles manufactured by Westlake Royal will pass applicable moisture absorption and transverse break strength tests under the conditions and using the methods applied by IAPMO Uniform Evaluation Service ("IAPMO") in report ER-411 that are in existence at date of manufacture and which are applicable to the Product. This warranty has been delivered to the original property owner(s) in connection with the original property owner(s) purchase of Westlake Royal clay roof tiles and remains in effect for as long as the original property owner(s) are living and are the owner(s) of the property for which the roofing was applied up to a maximum period of fifty (50) years. Please see below for warranty terms regarding transferability. For legal entities other than natural persons, the duration of the warranty is fifty (50) years and shall not be transferable.

Westlake Royal further warrants that the clay tile roofing products manufactured by Westlake Royal, after removal of foreign surface deposits and based on a comparison between the exposed and unexposed areas of a given tile, will not show a color fade in excess of 4 Hunter E Units as a result of normal weathering or ultraviolet exposure, for a period of twenty (20) years from date of original installation.

This warranty should be registered online at WestlakeRoyalRoofing.com within thirty (30) days after completion of installation of the roof tiles or purchase from the builder of your newly constructed home. This warranty is subject to the conditions, remedies, transfer requirements, limitations and legal rights stated in this warranty. All of the conditions and requirements stated in this warranty must be met in order to make this warranty valid.

NOTICE, INSPECTION, REMEDIES AND CONDITIONS:

Notice and Inspection: If you think your roof tiles are defective, you must contact Westlake Royal explaining your problem within ninety (90) days after your discovery at 1-800-669-8435(TILE) or email askcustomerservice@westlake.net. The date the roof tiles were installed or the date you purchased the home must be furnished to Westlake Royal.

If you choose to exercise your rights under this warranty, do not begin any repairs prior to writing Westlake Royal and receiving its permission to do so. Westlake Royal must have a reasonable opportunity to inspect and test the roof tiles before repairs are begun.

Remedies: If your roof tiles are found to be defective, in accordance with this warranty, Westlake Royal will furnish a new tile, free of charge, to replace each tile which fails the IAPMO tests or color fade tests. The manufacturer reserves the right to test all tiles before replacement. This warranty specifically excludes any obligation to pay the cost of labor to replace or reinstall the tiles for any defect. Also excluded are any labor costs required to correct improper installation or improper maintenance and all costs of materials required other than the replacement tiles.

Conditions: Westlake Royal reserves the right to discontinue or make changes in its roof tile products. If your roof tiles are not available and Westlake Royal decides to replace the defective roof tiles, Westlake Royal shall have the right to substitute roof tiles which it considers of substantially equal quality and price. Due to the nature of clay roof tiles, Westlake Royal cannot provide positive assurance of a perfect color match between different production runs. Therefore, it is understood that there may be a color difference between the original products installed and any replacement tiles provided under the terms of this warranty. All warranty claims shall be settled between you and Westlake Royal.

TRANSFER OF WARRANTY

This warranty is transferable by the original property owner(s), who are natural persons, while living, only to the next owner(s) of the property to which the roof tiles are attached, provided Westlake Royal receives electronic notice of the transfer of title of the property by re-registering the property online at WestlakeRoyalRoofing.com within thirty (30) days of the date of transfer of ownership. If you require assistance, please contact Westlake Royal at 1-800-669-8453(TILE) or e-mail askcustomerservice@westlake.net. Failure to file the required notice of transfer within such thirty (30) day period shall relieve Westlake Royal of any further obligation to the next owner(s) under the terms of the warranty. Upon meeting the above conditions of transfer, all warranty periods under this warranty, except for the above color fade warranty, shall be limited in duration to the life of the next following owner(s) for so long as such owner(s) own the property to which the roof tiles were applied, subject to a maximum period of fifty (50) years from the date of the installation. The color fade warranty as set forth above shall be limited to the time period of twenty (20) years.

This section does not apply to legal persons or entities who are not natural persons.



Maintaining Your US Tile® Roof

MILDEW, ALGAE AND MOSS

We recommend that a professional cleaning company be used, so that you avoid the dangers associated with walking on a wet tile roof.

Many climates across the country are conducive to mildew, algae and moss growth on everything from glass, stucco, siding and driveways, to roofing products including clay tiles. While this growth can result in a dirty surface appearance, it can be treated to restore the original look.

Mildew, algae and moss do not grow directly on the tile but grow on the accumulation of dust and other organic materials that settle on the tile. When enough cycles of heat, moisture and light are present, these spores start to grow.

Many environmental variables affect the potential for this organic growth. The location of the house, the direction the house is facing to the sun, and the quantity of trees, canals and lakes in the area can contribute to mildew growth.

Fortunately, mildew, algae and moss can be removed or treated. If the growth returns, the treatment can be repeated as necessary.

CLEANING

The following method is recommended to properly pressure clean the surface of your roof to remove dirt, algae, mildew or moss.

In most applications, a pressure cleaner set at approximately 1200 psi should be used. The tip of the nozzle of the pressure cleaner should be kept approximately one to two feet from the tile. The limited pressure and distance from the tile are used to prevent damaging the surface. Most modern pressure cleaners have an induction system to deliver a 10% solution of chlorine to water. This will help to temporarily remove the mildew, algae or moss when using the recommended reduced pressure.

WEATHERING EFFECTS

US Tile® clay roof tiles will be subjected to the worst nature can offer. The combination of elements that destroy most other roof coverings will not, however, seriously affect the protective properties of clay tiles. Over time, the surface of any product left unattended will show signs of aging, and clay roof tiles are no exception.

Clay tiles are produced by baking molded clay. The density of the clay is determined by the length of time and temperature at which it is heated. Colors of clay tiles range from shades of white, yellow, orange and brown. Clay tiles are primarily colored by the clay materials that are present during molding.

CHOOSING A CONTRACTOR

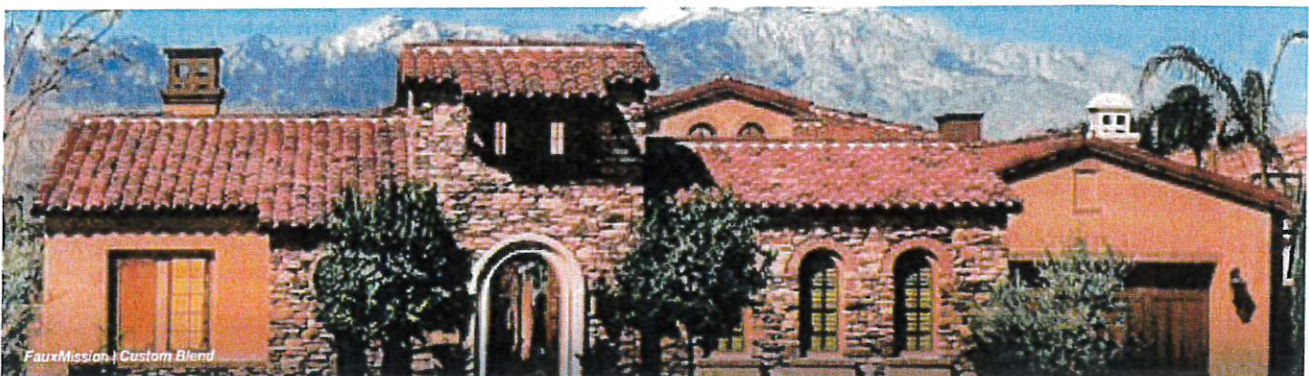
Regardless of whether you just want your roof inspected, (which should be done every couple of years), or have specific repair needs, you should take some precautionary steps in selecting a roofing contractor.

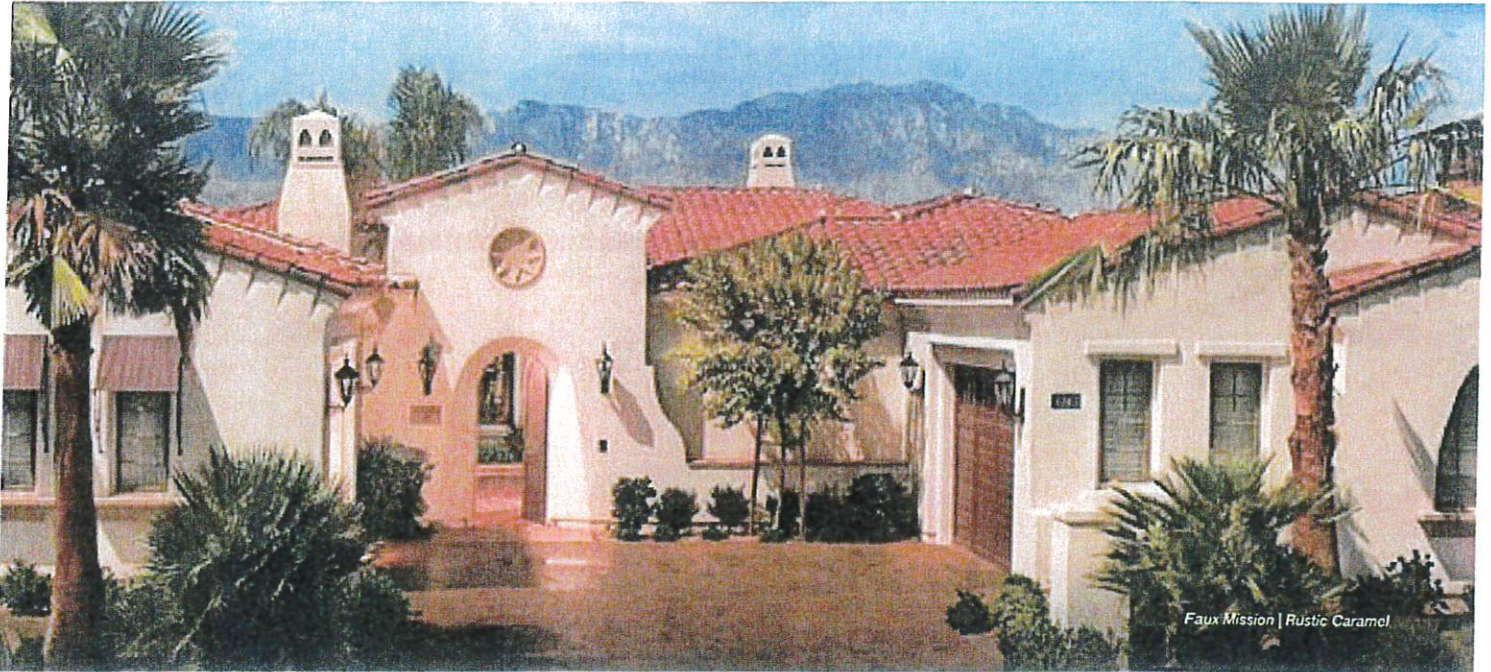
If your roof is still under warranty from the original installation, you should contact the original contractor for all inspections or repairs so that your original contractor's warranty is not voided.

Ensure that your contractor secures all necessary permits before any work begins or you may be responsible for any code violations.

Replacing broken tiles, removing algae, mildew and moss, or cleaning and re-coating your clay tile roof are all vital steps in maintaining its aesthetic and protective qualities for years to come.

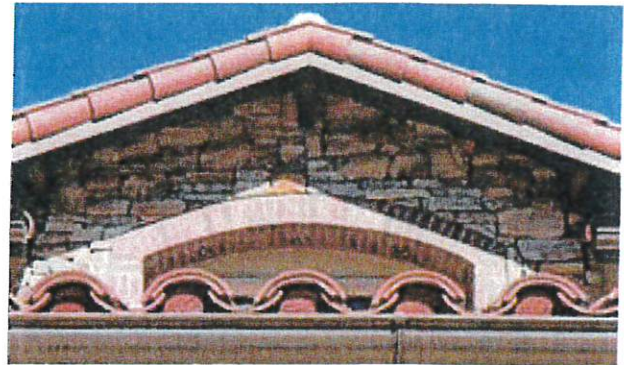

Avoid walking on your roof tile unless it is absolutely necessary

Do not walk on your roof unless you have adequate fall protection. Caution should be exercised to ensure your personal safety and prevent damage to roof tiles that may void your warranty. Roof traffic is specifically mentioned in the Special Exclusions section of your warranty. Roof tiles broken by foot traffic should be replaced as soon as possible. Broken tiles may allow penetration of water and UV rays to damage the waterproofing underlayment beneath the tiles.

There are certain methods of traversing the roof that may minimize damage. It is recommended you step at the bottom three inches of the installed tile. This section is supported by the lapped tile beneath it and the weight is then transferred through it to the deck below.

Keep in mind that activities such as cleaning gutters and hanging holiday lights can be accomplished from a ladder rather than walking on your roof. Ladder braces may be attached to avoid damage to your gutters and tiles.

Remember the following tips if you must walk on your roof tiles:

- Orient your feet in a horizontal direction. Try to distribute your weight evenly and walk as softly as possible.
- Distribute your weight on the high points of the adjacent tiles.
- A great option is to use walk pads to distribute your weight over a larger area. Pads may be fabricated in several ways but are typically made from sheets of plywood cut into 2" x 2" sections. The underside of these pads should be fitted with softer material such as carpet or rigid foam that will help distribute the weight and prevent slippage.
- Avoid walking on hips or valleys to prevent damage to specially cut tiles that are more difficult to replace.

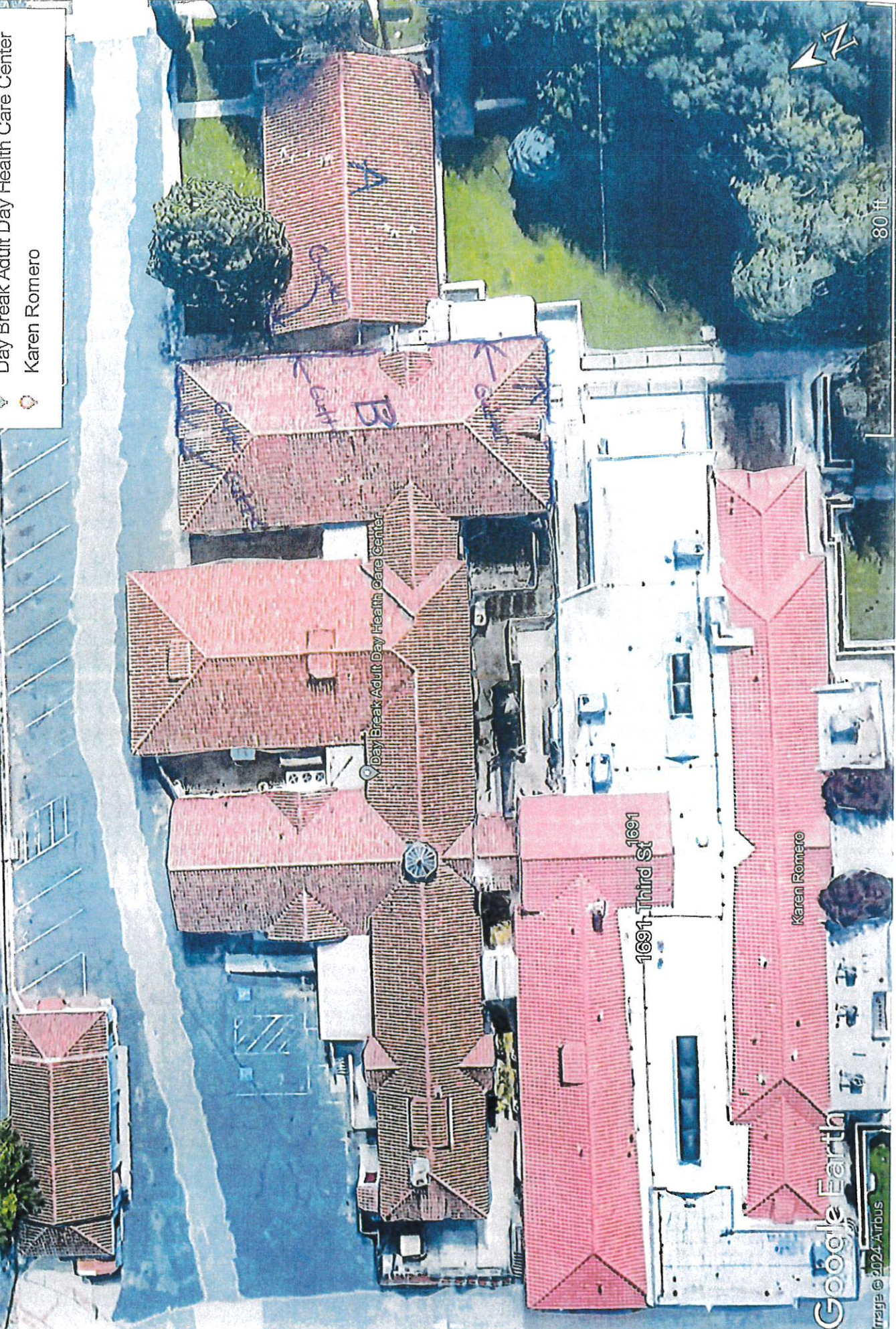
